Fees for fire protection system plan reviews and permits shall be as follows (as adopted by Des Moines City Council):

\$ 200.00	Fire Sprinkler System (modifying 20 sprinklers or less)
\$ 400.00	Fire Sprinkler System 0-10,000 square feet
\$ 550.00	Fire Sprinkler System 10,001-25,000 square feet
\$ 750.00	Fire Sprinkler System 25,001-50,000 square feet
\$ 1,000.00	Fire Sprinkler System 50,001-100,000 square feet
\$ 1,500.00	Fire Sprinkler System 100,001-200,000 square feet
\$ 2,000.00	Fire Sprinkler System 200,001-300,000 square feet
\$ 2,500.00	Fire Sprinkler System 300,001-400,000 square feet
\$ 3,000.00	Fire Sprinkler System 400,001-500,000 square feet
\$ 3,500.00	Fire Sprinkler System >500,000 square feet
\$ 400.00	Fire Alarm System 0-10,000 square feet
\$ 550.00	Fire Alarm System 10,001-25,000 square feet
\$ 750.00	Fire Alarm System 25,001-50,000 square feet
\$ 1,000.00	Fire Alarm System 50,001-100,000 square feet
\$ 1,500.00	Fire Alarm System 100,001-200,000 square feet
\$ 2,000.00	Fire Alarm System 200,001-300,000 square feet
\$ 2,500.00	Fire Alarm System 300,001-400,000 square feet
\$ 3,000.00	Fire Alarm System 400,001-500,000 square feet
\$ 3,500.00	Fire Alarm System >500,000 square feet
\$ 200.00	Kitchen Hood Suppression System (per hood)
\$ 450.00	Clean Agent or Other Suppression System 0-2,500 square feet
\$ 650.00	Clean Agent or Other Suppression System 2,501-5,000 square feet
\$ 900.00	Clean Agent or Other Suppression System >5,000 square feet
\$ 200.00	Addition of a Backflow Prevention Device to an existing sprinkler system
\$ 400.00	Standpipe system (not part of a sprinkler system)
\$ 250.00	Fire Alarm Control Unit (replacement or addition)
\$ 300.00	Other protection systems tied into the fire alarm system (e.g. delayed egress)
\$ 300.00	Fire Pump & related equipment (per pump)
1/2 Fee	Resubmittal of any fire protection system plans
2x Fee	Failure to obtain a permit prior to installation (may also be subject to stop work order) NOTE: additional fee is equal to the total of original fee + any resubmittal fees = 2x fee
