#### **AGENDA HEADING:**

Purchase of Crafco Pavement Crack Sealant (Roadsaver 221) and Detackifier (detack) to be used in crack sealing operations during Fiscal Year (FY) 2016.

## **SYNOPSIS:**

Recommend approval for City's Purchasing Agent to issue a blanket purchase order for Crafco Pavement Crack Sealant and Detackifier to Logan Contractors Supply (4101 106<sup>th</sup> Street, Urbandale, Iowa 50322, Bruce Logan, President), the sole area-wide distributor.

## ADDITIONAL INFORMATION:

The Department of Public Works utilities a Crafco SS125 Sealant Melter/Applicator extensively in its pavement maintenance program to seal cracks that develop in the pavement, thereby extending the pavement life. Crafco sealant is required to use in the Crafco Melter/Applicator. Municipal Code section 2-726(a)(7) provides for a non-competitive procurement of materials when the required materials are available only from a single area-wide distributor and competitive bids for such materials are not reasonably attainable. The cost for the sealant and detack price remained the same as the past three (3) years, \$.61 per pound and \$30 per pail respectively.
