AGENDA HEADING:

Ordering construction of the following: Indianola Avenue Widening - Phase 4 - Receiving bids, (6-16-15), and Setting date of hearing, (7-13-15). Construction Estimate - \$3,426,501.80.

SYNOPSIS:

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project is the fourth and final phase of the Indianola Avenue Widening project, which will reconstruct Indianola Avenue from E. Porter Avenue to Army Post Road to increase traffic capacity, improve safety, and provide pedestrian and bicycle accommodations. Also included in this project is a multi-use trail through Ewing Park. This project has been designed as a "complete street" that includes facilities for not only vehicular traffic, but also pedestrians, commuter and recreation bicyclists, and other recreational users.

FISCAL IMPACT:


Amount: \$3,426,501.80 City Engineer's Estimate

<u>Funding Source</u>: 2015-2016 Capital Improvement Program (CIP), Page Street – 19, Indianola Avenue Widening - S.E. 14th to Army Post Road, ST213, Being: \$2,309,640 (maximum) in Federal Surface Transportation Program (STP) funds being 80% eligible for roadway construction costs under STP-U-1945(747)—70-77, \$54,0000 from Des Moines Water Works for water main construction, and the remaining \$1,062,861.80 in G.O. Bonds.

ADDITIONAL INFORMATION:

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the Indianola Avenue Widening - Phase 4, 06-2015-001. The improvement includes reconstruction of Indianola Avenue with 10-inch thick full-depth Portland cement concrete; together with pavement removal, excavation, storm drainage, traffic signals, subdrain, subbase placement, driveways, sidewalks, trail, seeding, and miscellaneous associated work including cleanup; in accordance with the contract documents, including Plan File Nos. 568-001/166, on Indianola Avenue from E. Porter Avenue to Army Post Road, Des Moines, Iowa.

The estimated construction cost is \$3,426,501.80. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
