### **AGENDA HEADING:**

Ordering construction of the following: SE 22nd Street from Hartford Avenue to Park Avenue Partial Depth Repair - Receiving bids, (6-23-15), and Setting date of hearing, (7-13-15). Construction Estimate - \$457,000.

## **SYNOPSIS:**

Recommend the City Council proceed with construction of the improvement and set dates to receive bids and hold a public hearing, as required by Iowa Code, utilizing the method of financing referenced below. This project will maintain the existing pavement condition of SE 22nd Street by removal and replacement of deteriorated concrete pavement.

### **FISCAL IMPACT:**


Amount: \$457,000 City Engineer's Estimate

<u>Funding Source</u>: 2015-2016 Capital Improvement Program (CIP), Page Street – 8, Concrete Paving Restoration Program - Public Works, ST102, Being: \$228,500 in Road Use Tax Funds, and the remaining \$228,500 in G. O. Bonds.

### ADDITIONAL INFORMATION:

The Engineering Department has prepared plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the SE 22nd Street from Hartford Avenue to Park Avenue Partial Depth Repair, 06-2014-011. The improvement includes street rehabilitation by removal and replacement of partial depth and full depth Portland Cement Concrete pavement patches; all in accordance with the contract documents; including Plan File Nos. 569-085/101, located on SE 22nd Street between Park Avenue and Hartford Avenue, Des Moines, Iowa.

The estimated construction cost is \$457,000. The proposed plans, specifications, and form of contract documents are available for public inspection in the Des Moines City Engineer's Office.
