**Sean Devlin (NR-0), Plans Examiner,** to Washington, DC, from June 17 – June 20, 2015 (\$1,314) to participate as a governmental member on the consensus committee formed to assist in the development of the 2015 National Green Building Standard. The National Green Building Standard is a point-based rating system for sustainable residential construction, remodeling, and land development.

**Lawrence McDowell (R-0), Deputy City Attorney,** to Chicago, IL, from September 1 – September 4, 2015 (\$1,520) to attend the 2015 Brownfields Conference sponsored by the United States Environmental Protection Agency. The conference will focus on legal and practical issues related to environmental revitalization and economic redevelopment.
