## **AGENDA HEADING:**

Amending Section 42-258, relating to noise control.

#### **SYNOPSIS:**

Amends the noise control ordinance to bring the requirements for sound levels for enforcement purposes the same for Water Works Park as other large concert venues in the City.

FISCAL IMPACT: NONE

### ADDITIONAL INFORMATION:

- The noise control ordinance currently requires sound reading to be taken at the nearest property line adjacent to Water Works Park. Over the past several years staff has received complaints from those neighbors about the sound coming from concerts in the park.
- Brenton Skating Rink, Simon Estes, Sleepy Hollow and other outside venues are required to keep the sound at 100 dBC's measured 50 feet from the sound equipment. Currently it is measured at 85 dBC's when measured at the nearest residence.
- With this change staff will have a defined limit for sound across the multiple venues. Additionally, it will be easier to take sound readings when there is a complaint. Driving a neighborhood to find where the sound is in violation is difficult and not efficient.

(A) Final consideration of ordinance above, requires six votes. Moved by Coleman that the rule requiring that an ordinance must be considered and voted on for passage at two Council meetings prior to the meeting at which it is to be finally passed be suspended, that the ordinance be placed upon its final passage and that the ordinance do now pass, #15,566. Motion Carried 7-0.
