FISCAL IMPACT:

Amount: \$300,000

<u>Funding Source</u>: 2019-2020 Operating Budget, page 84, Engineering Department Traffic and Transportation – Traffic Engineering, EG062084. Costs for the Traffic Impact Studies are paid by developers.

ADDITIONAL INFORMATION:

• Three (3) on-call consulting firms are under contract to provide on-call Traffic Impact Study Services for the City regarding development projects within the City. As developments come forward, a supplemental professional service agreement (PSA) and scope of services specific to

the development project will be developed with the cost coming from the overall \$150,000 in the on-call agreement over the three (3) year period. Two (2) years into the program, there has been more development than anticipated. To continue the program through June 30, 2019, the not-to-exceed amount needs to be increased to \$250,000 for each consultant.

• Prior to authorizing a consulting firm to complete Traffic Impact Study services, the respective developer issues payment to the City to cover the entire cost of the study. If the study is completed for an amount less than proposed, the developer is reimbursed the difference.
