## **AGENDA HEADING:**

Approving the Renewal Agreement for Downtown Maintenance at Principal Riverwalk, East Locust Streetscape, Martin Luther King Jr. Parkway and Gateway West and exemption from the City's procurement ordinance requirements.

## **SYNOPSIS:**

Recommend authorization for the City Manager to execute a 5-year Renewal Agreement between the City of Des Moines and the Downtown Des Moines Self-Supported Municipal Improvement District (SSMID) relating to maintenance of the Principal Riverwalk, East Locust Streetscape, Martin Luther King Jr. Parkway and Gateway West.

## **FISCAL IMPACT:**

<u>Amount</u>: \$406,000 per year cash or in-kind (\$293,000 cash, \$113,000 in-kind)

<u>Funding Source</u>: Fiscal Year (FY) 2020, Operating Budget, Park and Recreation Department, Downtown Maintenance, G001, PK200225, page 164

# **ADDITIONAL INFORMATION:**

- On September 25, 2006, by Roll Call No. 06-1930, City Council approved the Management
  and Operations Agreement between the City of Des Moines, Riverfront Development Authority
  (RDA), and Des Moines Downtown SSMID for overall appearance, cleanliness, beautification
  and management of downtown's Gateway West, the Principal Riverwalk, Martin Luther King
  Jr. Parkway, and East Village Streetscape through the management firm of Operation
  Downtown, Inc. (OD).
- On May 9, 2016, City Council approved a 3-year renewal of the Agreement through July 1, 2019. The Agreement provided for required maintenance for these areas in a manner that is consistent with the standards of appearance, safety and functionality agreed to by an established committee of advisors known as the Advisory Oversight Committee (AOC), consisting of representatives of the City and RDA, which meets with OD staff to provide oversight. The Agreement specifically excludes management of programs and schedules, which are the responsibility of the Parks and Recreation Department.

- In the Agreement, the City is obligated to contribute \$406,000 in cash or in-kind service annually. In FY 2020, it is anticipated that approximately \$113,000 of this obligation will be met in the form of in-kind work, such as that which is detailed in the Downtown Maintenance Responsibility matrix attached to the blue letter, as well as through the assumption of the liability for the Principal Riverwalk. It is anticipated that a similar amount of in-kind service will offset the City's FY 2021 through FY 2024 financial obligation. The City will continue to have ongoing responsibility for capital repair and replacement of park and streetscape infrastructure apart from the \$406,000 maintenance funding.
- In addition to funding from the City of Des Moines, the Agreement requires the SSMID to provide up to \$725,000 in cash annually through FY 2024 to cover expenses.
- The Agreement provides for the SSMID, through OD, to act as the contracting authority for
  private contractors and to select the most qualified and economical vendors to do the required
  maintenance work. The City and RDA representatives in the AOC have the ability to voice
  their preference in this regard.
- This Agreement Renewal has been approved by the SSMID Board. If approved by Council, the 5-year renewal will commence on July 1, 2019 and expire on June 30, 2024. Significant points in the agreement include:
  - The City's cash contribution of \$293,000 (\$406,000 minus \$113,000 in-kind) will have an annual inflator or deflator not to exceed 3% annually based on increases or decreases in property tax valuations within the SSMID boundaries.
  - O Maintenance costs for E. Martin Luther King Jr. Parkway, from the Des Moines River to E. 9<sup>th</sup> Street, will be paid two-thirds by OD and one-third by the City. This allows OD to keep the contracts for plant maintenance, mowing, irrigation, and snow removal instead of stopping at the SSMID boundary at E. 7<sup>th</sup> Street which is in the middle of a median.
  - OD will continue to pay the City \$15,000 annually for Long Term Capital Repairs.

## **Long-Term Capital Repairs**

The City is responsible for Long-Term Capital Repairs. SSMID will provide \$15,000 annually to the City for such repairs. Long-Term Capital Repairs may include any of the following: site furniture repair/replacement; soil erosion repairs; bridge

decking repairs; electrical pedestals; emergency phones; landscaping replacement (plants, hardscape); fencing/railing; and light poles.

## City Responsibility

The City is responsible for the following items that are not to be included as part of the \$113,000 City services in-kind contribution: tree care; minor electrical repairs on East Locust, MLK and the bridges; brick pavers on East Locust and MLK; major electrical repairs; major plumbing repairs; major irrigation repairs; water feature repair/replacement; and concrete patching/repair/replacement/caulking.

<sup>\*\*</sup> Riverwalk General includes City Hall, Long Look Gardens and Armory landscaping and sidewalks, Hansen Triangle, Iowa Women of Achievement Bridge, and Red Bridge.

<sup>\*\*\*</sup> All horticulture/landscaping inside the Pappajohn Sculpture Park (with the exception of the outer sidewalk perimeter beds) will be performed by the City as part of the \$113k annual minimum in-kind city services.

<sup>\*\*\*\*</sup> Flood clean-up is assisting the City, but notification on timing for signage/barricades needed from City.
