ADDITIONAL INFORMATION:

- On February 11, 2019, under Roll Call No. 19-0235, the City Council approved plans and specifications and designated the lowest responsible bidder as Synergy Contracting, LLC, for \$7,388,888.30. This project provides for full reconstruction of the northbound lanes of Fleur Drive from Watrous Avenue to Bell Avenue and mill and overlay along Fleur Drive from Bell Avenue north to the viaduct over the Bill Riley Trail. The project also includes sidewalk construction along Fleur Drive from Park Avenue to the Gray's Lake Park entrance at George Flagg Parkway.
- Change Order No. 1 adjusted the asphalt binder mix from standard to high traffic.
- Change Order No. 2 added traffic signal and traffic control modifications.
- Change Order No. 3 includes adding sidewalk along the east side of Fleur Drive from Park Avenue to the entrance to Wakonda Golf Course.
