AGENDA HEADING:

Hearing on 2019 Neighborhood Sidewalk Program: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Ti-Zack Concrete, Inc., Steve J. Rutt, President, \$594,965.

SYNOPSIS:

This is a public hearing to allow for public input on the 2019 Neighborhood Sidewalk Program and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for the construction of new sidewalks and Americans with Disabilities Act (ADA) compliant sidewalk ramps as identified by the Engineering Department under the Neighborhood Sidewalk 3-year Program to connect gaps in existing sidewalk networks near schools and along priority pedestrian routes in neighborhoods throughout the City of Des Moines, Iowa.



ADDITIONAL INFORMATION:

- On May 20, 2019, under Roll Call No. 19-0776, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2019 Neighborhood Sidewalk Program. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2019 Neighborhood Sidewalk Program, 09-2019-003. The improvement includes furnishing labor, equipment, and materials all in accordance with the contract documents, including Plan File Nos. 611-064/066 for Site 10. Grading and construction of new 5-foot wide Portland Cement Concrete (PCC) sidewalks near the following locations, as inspected and identified by the City of Des Moines Engineering Department:
 - o Site 1: E. Euclid Avenue between E. 26th Street and E. 29th Street (both sides)
 - o Site 2: S.E. 8th Court from E. Bell Avenue to King Avenue (east side)

- Site 3: 918 E. Bell Avenue
- o Site 4: 2632/2628 S.E. 8th Street
- o Site 5: Watrous Avenue between S.W. 26th Street and Fleur Drive (north side)
- o Site 6: E. Payton Avenue from S.E. 3rd Street to S.E. 5th Street (south side)
- o Site 7: E. Hillside Avenue between S.E. 4th Street and S.E. 6th Street (south side)
- o Site 8: Scott Avenue between S.E. 28th Street and S.E. 30th Street (north side)
- o Site 9: 318/254 S.E. 30th Street
