

### **ADDITIONAL INFORMATION:**

- Phase 1 of the Fleur Drive Reconstruction George Flagg Parkway to Watrous Avenue Project
  includes reconstruction of the northbound lanes of Fleur Drive from George Flagg Parkway to
  Watrous Avenue. The purpose of the Project is to reconstruct deteriorated pavement and
  improve pedestrian mobility along the corridor through construction of sidewalks along Fleur
  Drive.
- City staff has reached an agreement with Wakonda Club for voluntary acquisition of the necessary right-of-way along Fleur Drive for construction of the roadway improvements and a public sidewalk adjoining Wakonda Club's property north of their driveway to Park Avenue.
- The compensation being provided to Wakonda Club includes the costs for land acquisition, replacement fencing, landscaping, and golf course repairs caused by the City's project.
- Wakonda Club will be responsible for making said golf course repairs and replacing all fencing and landscaping after the project is completed.
