ACCEPTANCE OF DEED RESTRICTION AND COVENANT ON CITY-OWNED PROPERTY LOCATED NORTH OF OLD ARMY POST ROAD AND EAST OF IOWA HIGHWAY 28 FOR THE ARMY POST BRIDGE OVER GREAT WESTERN TRAIL PROJECT

WHEREAS, the City of Des Moines is the owner of real property located north of Old Army Post Road and east of Iowa Highway 28 ("Restricted Property"), and such property contains Waters of the United States under the regulatory jurisdiction of the Rock Island District of the U.S. Army Corps of Engineers pursuant to Section 404 of the Clean Water Act (33 USC 1344); and

WHEREAS, the City of Des Moines received a Corps of Engineers permit (permit number CEMVR-OD-P-2012-1298) to place fill within Waters of the United States in accordance with plans for the Army Post Bridge Over Great Western Trail Project (also known as the Army Post Road Bridge Replacement Project); and

WHEREAS, as a requirement of receiving the Corps of Engineers permit and in consideration for allowing the City of Des Moines to place fill within Waters of the United States as part of said City project, the City of Des Moines must place a deed restriction and covenant upon the Restricted Property; and

WHEREAS, the deed restriction and covenant upon the Restricted Property, in the form on file with the City Clerk, includes various requirements including, but not limited to, perpetual use of the Restricted Property as a conservancy area, including a riparian buffer; restrictions on development and construction upon the Restricted Property of only utilities systems and conservation measures unless expressly approved in writing by the U.S. Army Corps of Engineers; change, modification or revocation of the restriction and covenant only upon express written approval of the Corps of Engineers; enforcement by the Corps of Engineers of the terms of the restriction and covenant; and a right of entry to the Corps for viewing, entering upon and inspecting the Restricted Property to determine City compliance with the restrictions.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa:

1. That the Deed Restriction/Covenant on City-owned real property located north of Old Army Post Road and east of Iowa Highway 28, legally described below, be and is hereby approved and accepted:
