SETTING DATE OF PUBLIC HEARING FOR ISSUANCE OF VEHICLE FOR HIRE COMPANY CERTIFICATE FOR NPI LIMO SERVICE, LLC

WHEREAS, by Roll Call No. 14-0651, City Council approved a one-year probationary company certificate for Brady C. Johnson d/b/a NPI Limo Service, LLC.

WHEREAS, the one-year probationary company license period has ended; therefore, Brady C. Johnson must now apply for a full Vehicle for Hire Company Certificate to continue operation.

WHEREAS, Section 126-230 of the Municipal Code forbids the operation of a vehicle as a vehicle for hire upon the streets of Des Moines without obtaining a Vehicle for Hire Company Certificate (VHC); and

WHEREAS, NPI Limo Service, LLC, has filed an application with the City Traffic Engineer requesting permission of the City Council to operate a vehicle for hire company in the City of Des Moines, which application is now on file in the office of the City Clerk for public review and consideration; and

WHEREAS, upon the filing of an application for a Vehicle for Hire Company Certificate, Section 126-234 of the Municipal Code requires the Traffic Engineer to determine if the application is complete and has met all requirements of Sections 126-231 and Section 126-232; and

WHEREAS, Section 126-234 does require that Council determine at a public hearing whether the applicant meets all requirements of this article for the issuance of a Vehicle for Hire Certificate.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA:

1. That the Des Moines City Council shall hear the matter of the request to operate a vehicle for hire company in the City of Des Moines at the regularly scheduled City Council meeting on June 22, 2015, in the City Council Chambers at 5:00 p.m.; and
