AN ORDINANCE vacating a portion of Robert D. Ray Drive north of Des Moines Street as a park road.

WHEREAS, all prior requirements of law pertaining to the vacation of public right-of-way have been fully observed; and

WHEREAS, it is desirable that the public right-of-way herein described be vacated;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Sec. 1. That a portion of Robert D. Ray Drive north of Des Moines Street as a park road, more specifically described as follows, be and is hereby vacated.

A PART OF LOT 5, BLOCK "D", RIVER HILLS PLAT THREE, AN OFFICIAL PLAT, NOW INCLUDED IN AND FORMING A PART OF THE CITY OF DES MOINES, POLK COUNTY, IOWA AND DESCRIBED AS FOLLOWS:
