#### ORDINANCE NO.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by repealing Section 114-1353.05 and by amending Sections 114-3605.06, 114-4108.05 and 114-4108.06, relating to rededication of Robert D. Ray Drive as public street right-of-way.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by

Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by repealing

Section 114-1353.05 and by amending Sections 114-3605.06, 114-4108.05 and 114-4108.06,

relating to traffic and vehicle regulations, as follows:

### Sec. 114-1353.05. Robert D Ray Drive Repealed by Ord. No. 15, ----.

-------Robert D Ray Drive, from a point 500 feet north of Des Moines Street to East Sixth Street, 35 miles per hour.

### Sec. 114-3605.06. Robert D Ray Drive--East Grand Avenue to Filmore Street.

Robert D Ray Drive, on the east side, from East Grand Avenue to Des Moines Street, no parking any time.

Robert D Ray Drive, on the west side, from East Grand Avenue to a point 40 feet north thereof, no parking any time.

Robert D Ray Drive, on the west side, from a point 115 feet north of Des Moines Street to a point 45 feet north thereof, commercial loading zone.

\_\_\_\_\_Robert D Ray Drive, on the west side, from a point 370 feet north of Des Moines Street to a point 50 feet north thereof, no parking any time.

Robert D Ray Drive, on the east side, from Des Moines Street to a point-525<u>1,700</u> feet north thereof, no parking any time.

Robert D Ray Drive, on the west side, from a point-<u>190</u> <u>280</u> feet north of Des Moines Street to a point-<u>290</u> <u>470</u> feet north thereof, official city vehicles.

\_\_\_\_\_\_Robert D Ray Drive, on the west side, from a point 480 feet north of Des Moines Street to a point 100 feet north thereof, no parking any time.

Robert D Ray Drive, on the cast side, from Des Moines Street to East Sixth Street, no parking any time.

# Sec. 114-4108.05. Robert D Ray Drive--Des Moines Street to just north of Des Moines Street.

Robert D Ray Drive, on the west side, from a point 25 feet north of Des Moines Street to a point 90 115 feet north thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Robert D Ray Drive, on the west side, from a point- $160 \underline{195}$  feet north of Des Moines Street to a point- $30 \underline{40}$  feet north thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

## Sec. 114-4108.06. Robert D Ray Drive--East Grand Avenue to Des Moines Street.

Robert D Ray Drive, on the west side, parking meter E-1-520, two hour meter, 8:00 a.m. to 6:00 p.m., is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

Robert D Ray Drive, on the west side, from a point 40 feet north of East Grand Avenue to a point-<u>325\_350</u> feet north thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Section 2. This ordinance shall be in full force and effect from and after its passage and

publication as provided by law.
