RECOMMENDATION FROM COUNCILMEMBER COLEMAN FOR REAPPOINTMENT OF CHAD LAYLAND TO THE BUILDING AND FIRE CODE BOARD OF APPEALS

WHEREAS, Chad Layland has previously served multiple consecutive terms on the Building and Fire Code Board of Appeals in Seat 3, which is required to be held by a professional electrical engineer; and,

WHEREAS, Chad Layland recently automatically ceased to be a member of the Building and Fire Code Board of Appeals because he is no longer a resident of the City of Des Moines; and,

WHEREAS, all attempts to find someone willing to serve on the Building and Fire Code Board of Appeals who resides in the City of Des Moines and has the experience and training to qualify for appointment to the vacant Seat 3 have been unsuccessful; and,

WHEREAS, Section 2-1049(d) of the Municipal Code establishes the residency requirement for City boards and commissions, and provides that the City Council may waive the residency requirement if the Council determines that no qualified city resident is available for appointment to a particular seat; and,

WHEREAS, by Ordinance No. 15,349 passed February 23, 2015, the City Council amended Section 26-121 of the City Code to provide that the City Council may waive the term limits imposed by Section 2-1059 of the City Code and reappoint an individual to a third or subsequent term on the Building and Fire Code Board of Appeals if it is determined that no other qualified person is available for appointment to a particular position on that Board; and,

WHEREAS, Mr. Layland, who resides at the following address:

Chad Layland 2329 MW Maple Street Ankeny, IA 50023

is uniquely qualified to fill the vacant Seat 3 on the Building and Fire Code Board of Appeals, and desires to continue serving the citizens of Des Moines in this capacity; and,

WHEREAS, Mr. Layland is recommended by Council Member Christopher Coleman for reappointment to Seat 3 on the Board for the remainder of the term expiring April 1, 2016.
