ACCEPTANCE OF SUBDIVISION IMPROVEMENTS BOND AND APPROVAL OF FINAL SUBDIVISION PLAT FOR WOODS ON THE RIVER PLAT 10

WHEREAS, the City Plan and Zoning Commission approved the preliminary subdivision plat on May 17, 2018; and,

WHEREAS, said subdivision plat conforms to Iowa Code Sections 355.8, 354.6, and 354.11, and said subdivision plat conforms to the standards and conditions set forth in Chapter 106 of the Municipal Code of the City of Des Moines, Iowa;

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. It is hereby determined that the subdivision plat identified above conforms to the PlanDSM: Creating Our Tomorrow Plan and the subdivision, with the required installation of public improvements, will not unduly burden public improvements in the area and will provide an appropriate balance of interests between current proprietors, future purchasers and the public interest.
- 2. The subdivision plat entitled Woods on the River Plat 10 is hereby approved, and subdivision bond rider IAC589098 from Merchant's Bonding Company, in the amount of \$90,735 has been received for the completion of the required public improvements including public sidewalk, trail, and curb installation within the plat, and approved by the City Legal Department.
- 3. The Mayor and City Clerk are hereby authorized and directed to execute approval on all copies of said subdivision plat as appropriate, and the City Clerk is further authorized and directed to certify to the City's acceptance on the permanent easements for public utilities, storm sewer, surface water flowage, sanitary sewer, and similar easements and agreements pertaining to the Woods on the River Plat 10.
- 4. Following execution by the Mayor and City Clerk as applicable, the City Clerk is hereby directed to provide the approved subdivision plat, a certified copy of this resolution, the attorney's title opinion and the attachments to the plat to the Developer for delivery to the County Recorder for recording by the plat proprietors.
