AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-1648, 114-1650.05, and 114-1738, and by adding and enacting new Sections 114-1649.02 and 114-1725, relating to snow routes.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-1648, 114-1650.05, and 114-1738, and by adding and enacting new Sections 114-1649.02 and 114-1725, relating to snow routes, as follows:

# Sec. 114-1648. Fifty-fifth Street.

Fifty-fifth Street, from Brattleboro Avenue to Franklin Avenue Hickman Road.

# Sec. 114-1649.02. Southwest Fifty-sixth Street.

Southwest Fifty-sixth Street, from Park Avenue to Thornton Avenue.

## Sec. 114-1650.05. Southwest Sixty-first Street.

Southwest Sixty-first Street, from Park Thornton Avenue to Willowmere Drive.

### Sec. 114-1725. Payton Avenue.

Payton Avenue, from Indianola Road to Southeast Thirty-sixth Street.

### Sec. 114-1738. Thornton Avenue.

Thornton Avenue, from Southwest Twenty-sixth Street to Southwest Twenty-eighth Street. Thornton Avenue, from Southwest Fifty-sixth Street to Southwest Sixty-third Street.

Section 2. This ordinance shall be in full force and effect from and after its passage and

publication as provided by law.
