



APPROVING COMPLETION AND ACCEPTANCE OF THE PAVING IMPROVEMENTS SET FORTH IN AND CONSTRUCTED PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT BRIDGE DISTRICT, BETWEEN ALLIANCE CONSTRUCTION GROUP, LLC AND BRIDGE DISTRICT TOWNHOMES, LLC

WHEREAS, on July 9, 2018 under Roll Call No. 18-1145, the City Council approved a private construction contract in the amount of \$29,210.80, between Alliance Construction Group, LLC, Dustin Jones, President, 3000 S.E. Grimes Blvd., Suite 800, Grimes, IA, 50111 - as Contractor, and Bridge District Townhomes, LLC, Rick Tollakson, President/CEO, 6900 Westown Parkway, West Des Moines, IA, 50266 - as Owner, for construction of Paving Improvements described as pavement widening for on-street parking on E. 2nd, E. 4th, and Maple Streets, to service the Bridge District, as shown on Plan File Nos. 594-269/272, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Paving Improvements in the amount of \$29,210.80, which have been constructed in substantial compliance with the contract documents between Alliance Construction Group, LLC and Bridge District Townhomes, LLC, which were approved under Roll Call No. 18-1145, dated July 9, 2018, be received and filed; and that completion of said Paving Improvements described as pavement widening for on-street parking on E. 2nd, E. 4th, and Maple Streets, to service the Bridge District, as shown on Plan File Nos. 594-269/272, is hereby acknowledged and that said Paving Improvements are hereby accepted.




