APPROVING COMPLETION AND ACCEPTANCE OF THE SIGNALS IMPROVEMENTS SET FORTH IN AND CONSTRUCTED PURSUANT TO SAID PRIVATE CONSTRUCTION CONTRACT, 701 GRAND AVENUE, BETWEEN BAKER ELECTRIC, INC. AND 7 & GRAND RAMP DEVELOPER, LLC

WHEREAS, on August 14, 2017 under Roll Call No. 17-1339, the City Council approved a private construction contract in the amount of \$153,636.00, between Baker Electric, Inc., Britt Baker, CEO, 111 Jackson Avenue, Des Moines, IA, 50315 - as Contractor, and 7 & Grand Ramp Developer, LLC, Dan Houston, Chairman, President & CEO, 711 High Street, Des Moines, IA, 50392 - as Owner, for construction of Signals Improvements described as signal installations at the northwest and northeast corners of 8th and High Streets, northeast corner at 8th Street & Grand Avenue, and the northwest corner at 7th Street & Grand Avenue, and associated miscellaneous items, in accordance with the contract documents and as shown on Plan File Nos. 572-242/247, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Signals Improvements in the amount of \$144,737.22, which have been constructed in substantial compliance with the contract documents between Baker Electric, Inc. and 7 & Grand Ramp Developer, LLC, which were approved under Roll Call No. 17-1339, dated August 14, 2017, be received and filed; and that completion of said Signals Improvements described as signal installations at the northwest and northeast corners of 8th and High Streets, northeast corner at 8th Street & Grand Avenue, and the northwest corner at 7th Street & Grand Avenue, and associated miscellaneous items, in accordance with the contract documents and as shown on Plan File Nos. 572-242/247, is hereby acknowledged and that said Signals Improvements are hereby accepted.


