**APPROVING AND AUTHORIZING THE EXECUTION OF
 IOWA INTERSTATE RAILROAD, LTD. STREET CROSSING
 SIGNAL SAFETY IMPROVEMENT AGREEMENT
 FOR 5th AVENUE**


WHEREAS, the City of Des Moines and the Iowa Interstate Railroad, Ltd. submitted a request for Federal Grade Crossing Safety Improvement Funds (Federal Aid 23 USC 130 Funds) for 5th Avenue, FRA No. 603720K; and

WHEREAS, the Iowa Department of Transportation has approved use of these funds for the Grade Crossing Safety Improvement for 5th Avenue, FRA No. 603720K, including installation of flashing light signals and automatic gate arm units, with the total cost of the project estimated at \$160,000 of which the City's participation is 5%, or \$8,000.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the agreement between the City of Des Moines and the Iowa Interstate Railroad, Ltd. for Grade Crossing Safety Improvements at 5th Avenue, FRA No. 603720K, be and is hereby approved subject to approval by the Iowa Interstate Railroad, Ltd., and the Mayor is authorized and directed to sign such agreement, and the City Clerk to attest to the Mayor's signature and return three original copies to the Engineering Department for transmittal to the Iowa Department of Transportation.




