APPROVING PURCHASE ORDER OF \$51,073.25 AND SELECT SUBSCRIBER PROGRAM AGREEMENT WITH BENTLEY SYSTEMS INCORPORATED, FOR SOFTWARE LICENSE RENEWAL AND SOFTWARE SUPPORT SERVICES

WHEREAS, the Information Technology Department and the Engineering Department desires to renew the Bentley MicroStation Software License with Bentley Systems, Incorporated, Antonio Ierardo, Vice President, 685 Stockton Drive, Exton, Pennsylvania, 19341, for thirty four (34) computers city-wide that have Bentley MicroStation Software installations; and

WHEREAS, Bentley Systems, Incorporated (Bentley) is the sole area-wide provider of this software and support services, and has licensed and provided support per existing licensing agreement, where said existing licensing expires June 18, 2015; and

WHEREAS, the Information Technology Department and Engineering Department staff recommend approval of the Select Subscriber Program Agreement to provide for licensing and support services for a three (3) year period of June 19, 2015 thru June 18, 2015, at a cost of \$51,073.25 for the first year, \$55,159.11 for the second year, and \$59,571.84 the third year; and

WHEREAS, Municipal Code section 2-276 (a)(7) provides for a non-competitive procurement of goods and/or service that are of such a nature that they are the only good and/or services which will fit and comply with the required use, or are an integral part of a total system so as to be uniquely compatible with existing city need, materials or equipment to be cost effective; and

WHEREAS, funding has been programmed in the Operating Budgets of the respective Departments that have Bentley MicroStation Software installations.

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the purchase order for software licensing and the software support services for a three (3) year duration at a cost of \$51,073.25 for the first year, \$55,159.11 for the second year, and \$59,571.84 the third year.

BE IT FURTHER RESOLVED: that the Select Subscriber Program Agreement between the City of Des Moines and Bentley Systems, Incorporated, Antonio Ierardo, Vice President, 685 Stockton Drive, Exton, Pennsylvania, 19341, to provide support services for city staff that utilize the design software, a copy of which is on file in the office of the City Clerk, is hereby approved as to form and content.

BE IT FURTHER RESOLVED: That the Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, said Select Subscriber Program Agreement for and on behalf of the City of Des Moines, Iowa.
